
## Monthly comment

In December, the Partners Group Listed Investments SICAV - Listed Infrastructure reported its second-best month of the year. Despite the sharp increase of Omicron cases globally, the Fund's portfolio developed positively, driven primarily by the less cyclical subsectors such as transmission & distribution, towers and water. During the year, all infrastructure subsectors contributed positively, showing resilient fundamentals with the only exception of airports. The Fund's relative outperformance was primarily driven by its overweight in towers, transmission & distribution, railways and waste managers albeit the relatively low allocation to pipelines, which was the strongest subsector in

One of the best performers was Sabesp, a Brazilian water and waste management company owned by the state of São Paulo. The share price rebounded in December as the State of São Paulo is still considering a privatization of the utility. Furthermore, the company reported better than expected water reservoir levels, as well as an updated 2022-26 capex program which was broadly in line with market expectations.

Another top performer was Atmos Energy, the largest gas distributor in Texas, whose share price recovered strongly in December. In particular, lower US natural gas prices during the month helped to ease investor concerns over high utility bills and a potential reduction in the capex program.

Finally, the US tower operator Crown Castle was another top performer during the reporting period. The US towers stocks performed strongly in December on the back of expectations regarding higher capital expenditure by telecom operators in 2022, leading to an increase in tower leasing activity.

## **Definitions**

comprise transportation infrastructure assets such as roads, airports, railways, harbours, tunnels and bridges. However, they also include assets of the communication infrastructure, such as TV and radio transmission systems, antennas and transmission towers for mobile phones, satellite systems and cable networks.
