Monthly comment

In February, the Partners Group Listed Investments SICAV - Listed Infrastructure remained broadly flat in a month where global equity markets dipped as volatility increased to the highest level in two years. The month started off with inflation concerns as the consumer price index increased more than expected, and the US Fed adopted an increasingly hawkish tone. Volatility persisted in the second half of the month following Russia's invasion of Ukraine. Oil and gas prices soared as a result of the conflict and the sanctions imposed by the US and Europe, leading to good performance of energy pipelines. The renewables sector also increased strongly, after several countries announced accelerated plans for renewable investments to become less energy-reliant on Russia. Towers and other growthoriented stocks performed worse in the month. In terms of regions, North America and China were weak, with all other regions delivered positive returns.

Orsted, the global leader in developing, constructing and managing offshore wind farms was among the best performers in February. Renewable stocks rallied strongly on the back of the Russia-Ukraine conflict, with increased pressure on governments to build more wind and solar power to reduce dependence on imported fossil fuels. The German government set a plan to get all its electricity from renewable energy by 2035, 15 years ahead of its previous goal for greenhouse-gas neutrality before 2050.

In contrast, tower operators such as American Tower & Crown Castle performed weakly. Investors have been reallocating away from growth stocks and more specifically REITs recently as inflation and rising interest rate concerns have intensified. However, we note that the tower companies are continuing to deliver strong business results, and have not witnessed any slowdown in business performance in the recent past.
