
## Monthly comment

In July, Partners Group Listed Investments SICAV – Listed Income continued to increase in value and established a dividend yield of the underlying portfolio of 6.2% at the end of the month. Since the beginning of the year, the Fund achieved a significant outperformance with a lower volatility compared to the broader equity market.

One of the strongest portfolio companies was US-based alternative asset manager Apollo Global Management. During the month, the company announced two new investments which have been well received by the market. One of the transactions is Diamond Resorts International, a holiday network owner offering nearly 350 vacation destinations located in 34 countries. The company was bought for USD 2.2 billion. Apollo Global Management's second investment is Outerwall, a network of movie and video game rental kiosks. The company was acquired for LISD 1.6 billion.

The Hong Kong-based real estate operator Link REIT also developed positively over the month. The REIT's first ever development project progresses faster than expected. Furthermore, the company profits form a newly set up financing initiative. Link REIT announced that it successfully priced a USD 500 million bond, due in ten years' time, at 2.875%. The bond was rated at A2 and A by Moody's and Standard & Poor's, respectively. The capital will be used for the financing of further investments.

The Australian airport operator Sydney Airport pleased its investors with a 5% increase in passenger traffic over the month of June compared to previous year. The airport has been used by 20.5 million passengers in the first half of 2016 accounting for a record half-year. Analysts expect Hainan Airlines' new route to Chinese megacity Changsha to further increase the growth of the airport.
