Monthly comment

 $In September, Partners \ Group \ Listed \ Investments \ SICAV-Listed \ Income \ saw \ a \ slight \ value \ increase \ outperforming \ broader \ equity \ markets.$

The top performers this month were Spectra Energy and Enbridge following their unexpected all-share merger announcement which will combine the two energy pipeline operators into the largest North American energy infrastructure company.

The share price of French waste, water and energy management company, Veolia Environnement, rose significantly on the news of winning a GBP 1.0 billion waste-to-energy contract in Southern England. This contract follows a GBP 338 million waste management contract with a London Borough that the company secured in August. In addition, by issuing an RMB 1.0 billion bond, Veolia became the first French company to tap the Chinese domestic bond market. The firm has been active in China for 20 years and the bond issuance proceeds will be used to support Veolia's growth objectives in China. In terms of capital employed, China features among the three largest countries in which the Group operates.

By contrast, the Australian natural gas pipeline operator, APA Group, contributed negatively to the Fund's performance as the company potentially faces regulated returns going forward (current tariffs are mostly market based). The stock has been a very strong performer over the last years benefitting from high growth and a near-monopolistic position in the Australian gas pipeline market.

Brookfield Infrastructure Partners performed well after announcing the acquisition of a 90% stake in Nova Transportadora do Sudeste, a South American natural gas transmission utility from Petroleo Brasileiro. The transaction is valued at USD 5.2 billion.
